EXPLANATION: A Master Plan to allow 30 residential lots with accessory equestrian and aviation

uses, clubhouse, maintenance facility and private airstrip (landing strip) for the 150 acre Flying Cow Ranch project.

SUMMARY: At the October 11, 2017 PZAB meeting, the Board postponed this item to the December 13, 2017 PZAB meeting to allow additional time for the applicant to discuss concerns raised at the meeting with the neighboring Aero Club and Palm Beach Point communities. The applicant and staff had a meeting with both communities on November 6, 2017.
