REQUEST: Authorization to award a three-year contract to Granicus, Inc. to provide licenses, maintenance and support for various existing government software suites, including the Village's existing legislative agenda software, Legistar, at a cost of \$84,044.13.

Staff is seeking authorization to award a three-year contract to Granicus, Inc., from date of award, for the licenses, maintenance and support of the government software suites detailed above, at a cost of \$84,044.13.
