REQUEST: Approval of Resolution No. R2018-43 approving and adopting a FY 2018/2019 Action Plan for the Community Development Block Grant Program.

EXPLANATION: The U.S. Department of Housing and Urban Development (HUD) has determined that Wellington qualifies as an "entitlement community" under the Community Development Block Grant (CDBG) Program. As such, Wellington is required to submit an Annual Action Plan to receive its annual allocation of CDBG funds.

The Village of Wellington will receive a FY 2018/2019 CDBG allocation of \$268,938, an increase of \$48,131 from the Village's FY 2017/2018 allocation of \$220,807. Consistent with the Village's proposed FY 2018/2019 budget, the CDBG funds are budgeted as follows:
