EXPLANATION: This is a petition for the replat of 3.8622 acres lying in Section 13, Township 44 South,

Range 41 East, Village of Wellington, Palm Beach County, Florida. The project site is located on the south side of Forest Hill Boulevard between Wellington Green Drive and Olive Drive. A location map is provided as Attachment 1. The owners of the property are Wellington FFI, LLC and Wellington Parking LLC. This is a replat of Tract 2 and Civic Tract for the expressed purpose of including the Wellington Park-n-Ride parking lot property for the required hotel parking spaces. The plat also provides the necessary access, water management and utility easements for the subdivision.

The plat is compliant with Wellington's codes and regulations.
