REQUEST: Authorization to award a contract to Link Electronics, to provide closed captioning services for all broadcasted Village meetings, in the amount of \$70,250 and approval of Resolution No. R2019-10 amending the General Fund Budget for the Fiscal Year 2019 in order to provide funding for closed captioning equipment and services; and providing an effective date.

EXPLANATION: In an effort to improve transparency and compliancy with the Americans with Disabilities Act (ADA), staff is seeking authorization to award a contract to Link Electronics, to provide the closed captioning service and equipment, for all broadcast Village meetings. The initial cost for the required service and equipment is \$70,250, and includes a one-year warranty, software version updates, firmware updates,

hardware maintenance and technical support.
