**REQUEST:** Approval of Resolution No. R2019-23 repealing Resolution No. R2000-42, creating an Education Committee, and providing for policies, procedures, purpose, powers and duties.

**EXPLANATION:** Resolution No. R2000-42 adopted on May 23, 2000 repealed prior Resolutions R98-57 and R99-31 and created an Education Committee. It also outlined the Committee's makeup as well as its powers and duties.

At its last few meetings, the Education Committee expressed a desire to revise its governing Resolution in order to bring it current and more accurately outline its mission.

A redline version of the revised Resolution is attached along with a clean version which incorporates all of the Committee's requested changes. The revised version was unanimously approved at the Committee's April 30, 2019 meeting.
