**EXPLANATION:** The Development Review Manual (DRM) has been adopted that provides the types of applications, details of the submittal requirements, and includes other miscellaneous information in a single document. Staff has updated the DRM to compile further information such as typical plan details or graphic depictions of standards as they relate to the zoning regulations and supplemental standards found in the LDR articles and will be processed as a companion request to Ordinance No. 2019-04 (Article 5 of the Land Development Regulations) On May 16, 2019, the Planning, Zoning and Adjustment Board recommended approval of Resolution No. R2019-15 with a 4-0 vote.
