ITEM: RESOLUTION NO. R2019-44 (COMMUNITY DEVLOPMENT BLOCK GRANT PROGRAM FISCAL YEAR 2019/2020 ANNUAL ACTION PLAN)

A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL APPROVING AND ADOPTING A FISCAL YEAR 2019/2020 ACTION PLAN FOR THE COMMUNITY DEVLOPMENT BLOCK GRANT PROGRAM; AUTHORIZING THE VILLAGE MANAGER TO PROVIDE THE PLAN TO THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD); AND PROVIDING AN EFFECTIVE DATE.

REQUEST: Approval of Resolution No. R2019-44 approving and adopting a FY 2019/2020 Action Plan for the Community Development Block Grant Program.

EXPLANATION: The U.S. Department of Housing and Urban Development (HUD) has determined that Wellington qualifies as an "entitlement community" under the Community Development Block Grant (CDBG) Program. As such Wellington is required to submit an Annual Action Plan to receive its annual allocation of CDBG funds.

The Village of Wellington will receive a FY 2019/2020 CDBG allocation of \$249,868. Consistent with the Villages proposed FY 2019/2020 budget, the CDBG funds are budgeted as follows:
