REQUEST: Approval of Resolution R2020-02 accepting and approving the Iron Spring Farm Plat.

EXPLANATION: This is a petition for the plat of 69.19 acres lying in Section 28, Township 44 South, Range 41 East, Village of Wellington, Palm Beach County, Florida. The project site is located on the south and west of Lake Worth Road and 130th Avenue South. A location map is provided as Attachment 1. The owner of the property is Meinse, LLC. This is a plat for the expressed purpose of developing six (6) parcels. The plat also provides the necessary ingress, egress, storm water management and utility easements for the subdivision.

The plat is compliant with Wellington's codes and regulations.
