REQUEST: Approval of Resolution No. R2020-28 approving and adopting an amendment to the five-year CDBG consolidated plan and fiscal year 2019/2020 action plan, to allocate funding under the Cares Act, and approval of Resolution No. R2020-27 amending the Fiscal Year 2019/2020 General Fund Budget for the CDBG Cares Act Funding.

EXPLANATION: The United States Department of Housing and Urban Development (HUD) has determined that the Village qualifies as an "entitlement recipient" and is eligible to receive funds under the Community Development Block Grant (CDBG) program. The Village adopted the 2019/2020 CDBG annual action plan on August 13, 2019, in the amount of \$249,868.

The United States Department of Housing and Urban Development (HUD), through the Cares Act, recently announced the allocation of funds for communities to bolster Coronavirus response and relief efforts. The Village is entitled to \$171,436 under this Act.

In order to receive funding, the Village must amend the FY 2019/2020 annual action plan to include the following:

Goshen 26 Passenger Bus - Transportation for Youth	\$104,503.00
Summer Camp Scholarships (B&G and Village Park Athletic Camps)	\$32,646.00
Planning and Administration (Capped at 20% of the Cares Act allocation)	\$34,287.00
Total:	\$171,436.00
