REQUEST: Acceptance of the Florida Department of Law Enforcement Coronavirus Emergency Supplemental Funding (CESF) to be used to prepare for, prevent, and respond to the pandemic, and the Budget Amendment providing for the reimbursement of \$174,820.

EXPLANATION: Staff requests Council approval and authorization to execute the Florida Department of Law Enforcement (FDLE) Coronavirus Emergency Supplemental Funding (CESF) Subaward and Grant Agreement. This funding agreement provides funds for eligible emergency protective measures due to the COVID-19 pandemic. Wellington has expended funding to apply for reimbursement of \$174,820 in emergency protective measures due to COVID-19 as awarded by the FDLE Local CESF allocation.
