A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL APPROVING AND ADOPTING THE FY 2020/2021 ANNUAL ACTION PLAN FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM; AUTHORIZING THE VILLAGE MANAGER TO FORWARD THE FY 2020/2021 ANNUAL ACTION PLAN TO THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT; AND PROVIDING AN EFFECTIVE DATE.

REQUEST: Approval of Resolution No. R2020-32 approving and adopting a FY 2020/2021 Action Plan for the Community Development Block Grant Program.

EXPLANATION: The U.S. Department of Housing and Urban Development (HUD) has determined that Wellington qualifies as an "entitlement community" under the Community Development Block Grant (CDBG) Program. As such Wellington is required to submit an Annual Action Plan to receive its annual allocation of CDBG funds.

The Village will receive an FY 2020/2021 CDBG allocation of \$291,425. The proposed FY 2020/2021 CDBG budget presented in the attached Action Plan is as follows:

Rental Housing Assistance Program	\$ 71,570
Senior Transportation and Rides Program	\$ 40,000
Youth Services (Mentoring/Employment)	\$ 50,000
