**REQUEST:** Ratification of Resolution No. R2020-66A for Diversity Consulting Services with K. Michael Slater in an amount not to exceed \$65,000.

**EXPLANATION:** At the January 26, 2021 Diversity, Equity, Inclusion and Belonging Workshop Meeting, Council approved the contract for services with K. Michael Slater in an amount not to exceed \$75,000. Of this, \$10,000 was approved at their December 8, 2020 Council meeting with Resolution No. R2020-66. The attached Resolution No. R2020-66A amends the General Fund budget for the remaining not to exceed amount of \$65,000.
