REQUEST: Approval of Resolution No. R2021-24 Approving Opioid Litigation Memorandum of Understanding and Agreements and authorizing the Mayor and Clerk to Execute the MOU.

EXPLANATION: The State of Florida filed an action against various pharmaceutical companies, including Purdue Pharma, Mallinekrodt, Johnson & Johnson and other manufacturers of opioids concerning the ongoing opioid epidemic. The suit is pending in Pasco County, Florida and a number of Florida Cities and Counties have filed separate, related actions. (The "Opioid Litigation"). Wellington is not a party to any of these actions.

The State of Florida and lawyers representing certain various local governments involved in the Opioid

Litigation have proposed a unified plan for the allocation and use of prospective settlement dollars from opioidrelated litigation.

The Memorandum of Understanding (the "Florida Plan") sets forth a framework of a unified plan for the proposed allocation and use of opioid settlement proceeds and it is anticipated that formal agreements implementing the Florida Plan will be entered into at a future date. The participation by a large majority of Florida cities and counties will materially increase the amount of funds to Florida and should improve Florida's relative bargaining position during additional settlement negotiations. Failure to participate in the Florida Plan will reduce funds available to the State, the Village of Wellington and every other Florida City and County.

The State believes that the proposal reflects a reasonable compromise between the State and its political subdivisions. The state is requesting that participating municipalities adopt a resolution authorizing participation in the Florida Plan and authorizing the Mayor to execute any formal agreements implementing a unified plan for the allocation and use of opioid settlement proceeds that is not substantially inconsistent with the Florida Plan.
