## ITEM: AUTHORIZATION TO AWARD CONTRACTS FOR ANNUAL PATHWAY AND MINOR CONSTRUCTION

**REQUEST:** Authorization to award contracts for Annual Pathway and Minor Construction for Public Works, Engineering, and Utility projects.

**EXPLANATION:** Public Works, Utilities, and Engineering Departments use Annual Pathway and Minor Construction contracts for sidewalk repairs and replacement, directional drilling, seeding and mulching, conduit installation, drainage repairs, and other similar projects.

On March 15, 2021, Wellington released ITB #202112 on Demandstar, seeking qualified firms to provide such services. The solicitation was also advertised in the Palm Beach Post and posted on Wellington's website. On April 14, 2021, four (4) proposals were received.
