**A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL APPROVING AND ADOPTING THE FY 2021/2022 ANNUAL ACTION PLAN FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM; AUTHORIZING THE VILLAGE MANAGER TO FORWARD THE FY 2021/2022 ANNUAL ACTION PLAN TO THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT; AND PROVIDING AN EFFECTIVE DATE.**

**REQUEST:** Approval of Resolution No. R2021-34 approving and adopting a FY 2021/2022 Action Plan for the Community Development Block Grant Program.

**EXPLANATION:** The United States Department of Housing and Urban Development (HUD) has determined that Wellington qualifies as an "entitlement community" and is eligible to receive funds under the Community Development Block Grant (CDBG) program. As such, Wellington is required to submit an Annual Action Plan to receive its annual allocation of CDBG funds.

The Village of Wellington will receive a FY 2021-2022 CDBG allocation of \$296,315. Consistent with the Villages proposed FY 2021/2022 budget, the CDBG funds are budgeted as follows:

Housing Rehabilitation Program	\$183,250
Housing Rehabilitation Administration	\$10,000

Senior Transportation Program	\$20,000
Youth Services (Mentoring/Employment)	\$23,802
Planning & Admin	\$59,263
Total FY 2021/2022 CDBG Entitlement Allocation	\$296,315
