REQUEST: Approval of Ordinance No. 2021-14, a Comprehensive Plan Text Amendment (CPTA) to repeal and replace the entire Comprehensive Plan (excluding the Capital Improvements Element).

EXPLANATION: The Wellington Comprehensive Plan is being updated. The Plan forms the blueprint for Wellington's future for the next 10 to 20 years. The Plan is comprised of 10 "elements" or chapters and each element consists of goals, objectives, and policies to guide development and redevelopment, transportation, infrastructure, parks, and capital improvements. The Plan includes several optional elements, such as the

Equestrian and Education Elements, focused on community priorities generally unique to Wellington. Each element is comprised of goals, objectives, and policies to address statutory requirements as well as community priorities.

The update of the Plan was presented to the Planning, Zoning, and Adjustment Board over the course of several months and the PZAB recommended approval of all elements at the following meetings:
