REQUEST: Authorization to award a task order to Mock, Roos & Associates, Inc. to provide engineering consulting services for the Village of Wellington's Tennis Center Improvements Design for a cost of \$133,530.

EXPLANATION: On September 28, 2021, Council awarded an engineering services contract (RFQ 202121) to multiple vendors. As part of the solicitation, Mock Roos & Associates, Inc, was selected as one of Wellington's engineering service providers. Staff is seeking authorization to utilize such contract with Mock, Roos & Associates, Inc. to provide consulting services for the Tennis Center Improvements Design Project.
