ITEM: AUTHORIZATION TO UTILIZE EXISTING CONTRACTS FOR THE AERO CLUB DRIVE SHOULDER WIDENING PROJECT

REQUEST: Authorization to utilize existing contracts for the Aero Club Drive Widening Project at a cost of 1,051,653.81.

EXPLANATION: The Engineering Department is seeking authorization to utilize existing contracts for the Aero Club Drive Widening Project. The project includes widening approximately two (2) miles of Aero Club Drive by six (6) feet (from Greenbriar Boulevard to Meadow Wood Drive). The project also includes partial swale restoration, pavement mill/overlay, and re-striping of the existing roadway.
