REQUEST: Approval on First Reading of Ordinance No. 2022-25 amending the Code of Ordinances by repealing and replacing Chapters 1, 2, 3, 6, 14, 18, 22, 23, 26, 27, 30, 33, 35, 36, 38, 42, 46, 50, 54, 58, 62, 66, 70, 71, and 72 in their entirety.

EXPLANATION: Wellington's Code of Ordinances currently spans 72 Chapters. Council considered and approved the first reading of the Code in three separate parts: Chapters 1 through 8 were approved on November 9, 2021; Chapters 9-16 were approved on January 25, 2022; and Chapters 17-24 were approved on June 14, 2022. The entire redrafted and reorganized Code of Ordinances is now being presented for adoption. All of the prior ordinances previously approved on first reading are consolidated into the new Ordinance No. 2022-25. This item is the first reading of the consolidated ordinances. The second reading will

follow in September, along with second reading of the “cleanup” ordinance, and the resolutions reestablishing the boards and committees and adopting the public assembly policy.
