**REQUEST:** Approval of Resolution No. R2022-54 authorizing the Mayor to enter into an agreement with the Florida Department of Environmental Protection Recreational Trails Program Grant for the Wellington Environmental Preserve Boardwalk Project (T2104); and approval of Resolution No. R2022-55 for the Budget Amendment in the amount of \$400,000 for said grant.

**EXPLANATION:** The Florida Department of Environment Protection administers the Recreational Trails Program (RTP) which funds project that construct, renovate or maintain trails, trailhead, and trailside facilities. This RTP Grant includes funding of \$400,000 with a \$100,000 match from Wellington for replacement of the two boardwalks in the Wellington Environmental Preserve.

Approval of Resolution No. R2022-54 authorizes the mayor to enter into the agreement for the grant, and Resolution No. R2022-55 amends the capital budget for the grant funding of \$400,000.
