ITEM: AUTHORIZATION TO UTILIZE EXISTING CONTRACTS AND AWARD SOLE SOURCE CONTRACTS FOR VARIOUS FY 2023 PUBLIC WORKS PROJECTS

REQUEST: Authorization to utilize existing contracts and award sole source contracts for various FY 2023 Public Works Projects with a budgeted total amount of \$4,126,000.00.

EXPLANATION: The Public Works Department is seeking authorization to utilize existing contracts and award sole source contracts for various FY 2023 projects exceeding the Village's \$50,000 threshold.

The projects include: 1) Roadway milling, resurfacing, traffic striping, valley gutter and sidewalk maintenance 2) Swale maintenance and reconstruction, canal desilting, drainage pipe cleaning, lining and inspection 3) Pump Station 7 water lube conversion 4) Reconditioning trash rake at pump station 3.
