REQUEST: Approval on Second Reading of Ordinance No. 2022-25 amending the Code of Ordinances by repealing and replacing Chapters 1, 2, 3, 6, 14, 18, 22, 23, 26, 27, 30, 33, 35, 36, 38, 42, 46, 50, 54, 58, 62, 66, 70, 71, and 72 in their entirety.

EXPLANATION: Wellington's Code of Ordinances currently spans 72 Chapters. Council initially considered and approved the first reading of the Code in three separate parts: Chapters 1 through 8 were approved on November 9, 2021; Chapters 9-16 were approved on January 25, 2022; and Chapters 17-24 were approved on June 14, 2022. All of the prior ordinances previously approved on first reading were consolidated into new Ordinance No. 2022-25, which was presented to and approved by Council on first reading on August 9, 2022. The adoption of Ordinance No. 2022-25 on second reading, followed by the resolutions reestablishing the

boards and committees and adopting the public assembly policy, will conclude the rewrite of the Code Ordinances into 24 consecutively numbered chapters.
